The American Legion Department of Utah and The American Legion Utah Boys State will soon enjoy the distinct privilege of having your son in attendance for the Utah Boys State Class of 2011 which will be held from June 6th through 10th, 2011 on the campus of Weber State University in Ogden, Utah. This week long course offers a forum in Citizenship, Self-Government and Public Service.

Group of adult leaders will supervise the entire session. Every precaution is taken to avoid accidents or illness and to maintain the health and safety of our citizen students. A first aid station with competent technicians is set up on the campus. Physicians and a hospital are also available at all times.

Participants who do not already have group accident-sickness medical insurance coverage are insured under a group policy underwritten by Sentry Insurance. The Sentry policy is secondary excess coverage to any other valid or collectible group insurance plan and pays up to allowable (normally up to but not more than \$2,000.00) per illness. Any billing above your insurance and that provided by Utah Boys State is the responsibility of the parent or legal guardian. (This exclusion does not apply to individual accident and sickness policies.) Should a need arise for this insurance program, more detailed information will be sent directly to you at the time by the American Legion Utah Boys State Inc.

We urge you to send your son to Ogden, Utah via common carrier, which will protect them in route, or you may contact your local American Legion Post with regard to transportation.

To further impress the importance of health and safety upon your son, and as a reasonable safeguard to the American Legion, you are asked to sign the following statement.
